- ☐ CO AGRICULTURAL LABOR RIGHTS & RESPONSIBILITIES POSTER (#06400, #06401) – Required for all Colorado agricultural employers.
- ☐ CO ON-PREMISES ALCOHOL POSTER – Required in spaces licensed for on-premises alcohol consumption (i.e., hotels, restaurants, taverns, art galleries). Small poster format for general licensees (#06710). Large poster format for gaming taverns (#06711).
- ☐ CO DRINKING AGE POSTER – Must be posted by Colorado liquor and beer retail licensees. (#06715, #06720).



- ❑ CO PUBLIC ACCOMMODATIONS POSTER – Must be posted in accessible and well-lit places customarily frequented by people seeking services, purchases, facilities, privileges, advantages, or accommodations offered to the general public. Bilingual (#06703).
- ❑ CO HOUSING DISCRIMINATION POSTER – Must be posted by real estate brokers or agents, home builders, home mortgage lenders, and all other persons who transfer, rent, or finance real estate. Bilingual (#06717).
- ❑ CO WORKERS' COMPENSATION FRAUD POSTER – Recommended poster. English (#06300)
- ❑ DENVER, CO ANTI-DISCRIMINATION POSTER – Required for all employers operating in the City or County of Denver with 20+ employees. English (#06705), Spanish (#06706).
- ❑ DENVER, CO MINIMUM WAGE POSTER – Required for every employer with an employee who works 4 or more hours per week within the City and County of Denver. Bilingual. (#06716)
- ❑ EDGEWATER, CO MINIMUM WAGE POSTER – Required for every employer with an employee who works 4 or more hours per week within City limits. Bilingual. (#06303)
