ADDITIONAL WORKPLACE POSTERS

- ☐ FL LODGING AND FOOD ESTABLISHMENTS POSTER – Restaurant and lodging facilities are required to post in a prominent place within the establishment. (#09500)
- ☐ FL DEPT. OF HEALTH HUMAN TRAFFICKING POSTER – Must be posted in emergency rooms of acute care hospitals, massage establishments not owned by a health care practitioner, and adult entertainment businesses. (#09727)
- ☐ FL HUMAN TRAFFICKING PUBLIC AWARENESS POSTER – Must be posted in lodging and food service establishments. (#09301)
- ☐ FL ALCOHOL UNDER 21 POSTER – This poster is mandatory for participants in Florida's Responsible Vendor Program and recommended for all premises licensed to sell alcohol. Posting demonstrate awareness and compliance with the law which prohibits the sale or serving of alcohol to persons under 21. (#09701)
- ☐ FL PATIENT'S BILL OF RIGHTS AND RESPONSIBILITIES – May be posted by health care facilities. (#09203)
- ☐ FL NURSING HOME BILL RIGHTS – May be posted by nursing homes. (#09201)
- ☐ FL BILL OF RIGHTS FOR RESIDENTS OF ASSISTED LIVING FACILITIES – Must be posted by assisted living facilities. (#09716)
- ☐ FL CITY AND COUNTY ALCOHOL POSTERS – Businesses which sell or dispense alcohol are required to post municipal posters in Hillsborough County (#09712), Jacksonville (#09711), Miami-Dade County (#09713 & #09708), Orange County (#09709), Palm Beach County (#09710), and Pinellas County (#09202).
- ☐ PINELLAS COUNTY, FL WAGE THEFT/RECOVERY POSTER – All private employers in the County must display. (#09715)
