- ☐ ME HUMAN TRAFFICKING POSTER – Required for hotels, strip clubs, money transmitters, check cashing and foreign currency exchange establishments, and medical facilities which provide emergency medical services. (#19300)
- ☐ ME WORKERS' COMPENSATION FRAUD POSTER – Optional poster that provides examples of common forms of workers' compensation fraud and describes the penalties for violating the law. (#19301)
- ☐ ME SOCIAL MEDIA POSTER – Optional poster covering the Maine Employee Social Media Privacy Law, which prohibits employers from requiring an employee to disclose personal social media acct. information. (#19701)
- ☐ ME EQUAL PAY LAW POSTER – Optional poster covering Maine's Equal Pay Law, which prohibits sex discrimination in payment of wages. (#19702)
