- ❑ MN PREGNANT WORKERS AND NEW PARENTS POSTER – Optional poster that outlines workplace rights and protections for pregnant workers and new parents. (#23308 Bilingual)
- ❑ MN EARNED SICK AND SAFE TIME POSTER – Optional poster that summarizes the Minnesota Earned Sick and Safe Time Law. (#23200)
- ❑ MN BAN GUNS POSTER – Post at entrance of a private establishment to notify permit handgun holders that firearms are not allowed in the building. (#23700)
- ❑ MN SERVICE ANIMALS POSTER – Post in a retail store, hotel, or other place of public accommodation to let patrons know that service animals are welcome but misrepresenting a pet as a service animal is a crime. (#23704)
- ❑ MN NO SMOKING POSTER – Employers and operators of places of employment and public places must make efforts to deter smoking, including by posting appropriate signage. (#23701)
- ❑ MN CONTRACTOR NON-DISCRIMINATION POSTER – All businesses contracting with the State of Wisconsin, cities, counties, and the University of Minnesota must display this poster. (#23600)
- ❑ MN WORKERS' COMPENSATION FRAUD POSTER – Optional poster that provides examples of common forms of workers' compensation fraud and describes the penalties for violating the law. (#23300)
- ❑ MN PATIENTS' BILL OF RIGHTS POSTER – Hospitals must display this poster in clearly viewed areas. (#23306)
- ❑ BLOOMINGTON PAID SICK LEAVE POSTER – Employers with five or more employees in the City must display this poster. (#23725)
- ❑ DULUTH EARNED SICK AND SAFE LEAVE POSTER – Employers with five or more employees in the City must give notice to employees. Employers can comply by displaying poster. (#23302)
- ❑ MINNEAPOLIS EMPLOYMENT RIGHTS – Employers in the City must display this poster. (#23702)
- ❑ SAINT PAUL FOOD ALLERGY POSTER – Food establishments with a restaurant license in the City must display this poster. (#23500)
- ❑ SAINT PAUL MINIMUM WAGE & EARNED SICK AND SAFE LEAVE POSTER – Employers in the City must give notice to employees. Employers can comply by displaying this poster. (#23301)
